During the 2018-2019 school year EEF awarded 102 classroom grants for educator-initiated projects benefitting students at 31 schools. EEF awarded 19 college scholarships to graduating TUSD seniors and provided funding for 1539 interscholastic participation fees assistance to all 9 TUSD high schools and 21 middle schools. EEF provided students in need with 205 professional eye exams and/or prescription eyeglasses; 1594 pairs of shoes and 2808 pairs of socks were given to students at "shoe shopping" party events; and \$70,978 in clothing, shoes, hygiene products, and classroom supplies were distributed to TUSD title 1 schools. Additionally, EEF distributed \$1,000 in leadership awards to TUSD high school juniors.
